The ATN Board of Directors meeting was called to order at 11:03 am

1. Approve Resolution #14-003 of the Board of Directors of the Anaheim Transportation Network approving:



- a) Certain loans and letters of credit endorsing ATN Refinance Sub-Committee recommendation, in response to RFP 2014-07 Refinancing of ATN Facilities at 1354 South Anaheim Boulevard, Anaheim;
- b) Property and tenant improvement loans refinancing to Bank of America® Corporation;
- c) Authorize ATN Executive Director and ATN legal counsel, to negotiate and execute final loan documents for up to eighty percent (80%) of the Loan to Value (LTV) ratio based on the property appraisal dated October 9, 2014.
- 2. Approve Resolution #14-004 of the Board of Directors of Anaheim Transportation Network approving a change in its banking institution
- 3. Authorize Executive Director to release Invitation for Bid (IFB), using proceeds from refinancing, to complete tenant improvements of the ATN property for re-surfacing of the parking facilities and mechanization of the fence

Staff and ATN Refinance subcommittee members provided an overview of the refinance terms and conditions with the recommendation for the award of the refinancing loan to Bank of America.

Director Kim asked if we could request Bank of America to raise the loan amount to the amount approved by Citizens Business Bank. Chairman Sanford responded that right now the rates are at rock bottom. He added that Bank of America offer is an "11 out of 10" and there is not a lot of room for negotiation. Fred Whitaker said that the Citizens Bank appraisal came in too low.

Director Kim also asked about the Loan to Value ratio. Chairman Sanford responded that we had asked the question and that they said they can give the whole amount for tenant improvements.

Director Morton asked if there are any penalties for pre-payment? There are no pre-payment penalties on the existing loan with Citizens Business Bank.
