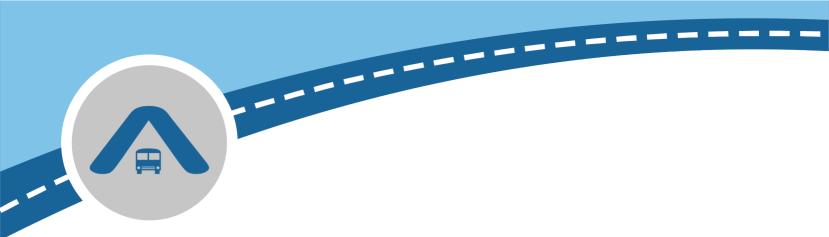

OPERATIONAL REPORT:

10. ART Operational Update - Report provided by Parking Company of America (PCA)

Aaron Chavez, PCA – Transition of Anaheim Resort Transportation Service from Transdev to PCA effective Wednesday, August 28, 2019

Aaron Chaves, Vice President of Operations of PCA provided an update concerning the recruitment and onboarding of Operators.

11. Overview of ATN new facility design and construction processes to house 40 Zero Emission Buses on order with BYD, USA. Award consulting agreement to render Owner's Representative construction management services to IBI Group and DHS Consulting

DISCUSSION:

Director Kotler presented information, as outlined in the Staff Report to the Board of Directors.

Chairman Sanford states that the design of the building needs to have community and board involvement, must have branding on façade. Legal Counsel Fred Whitaker states that ATN is required to get final approval from the city.

Chairman Sanford emphasizes to ensure that we don't rush and that we focus on all components, including façade of the building.

Chairman Sanford asks if we have negotiated to have a marketing component (e.g., communications, branding and public relations) to brand and advised director Kotler to work with groups. Director Kotler states that from the public relations perspective, Todd Priest & Associates will communicate progress to the community

12. Review and approve Anaheim Transportation Network (ATN) Ad Hoc Committee recommendations to amendment Anaheim Resort Transportation (ART) retail assessment rates. Authorize ATN to work with City of Anaheim to update mitigation monitoring processes for future developments

DISCUSSION:

Director Kotler presented information, as outlined in the Staff Report to the Board of Directors and explains that the current retail rate is based on the Board decision dating back 7-8 years and that the new retail assessment structure needs to include new developments, including mixed-use developments. Instead of the current non-equitable approach of "one-size-fits-all", the new retail assessment addresses the differences between a free-standing business versus an adjoining development.

IBI Group Representative, Steve Wilks, discusses the assessment methodology and strategy to the Board of Directors. Director Kotler explains that there are three components that will carry ongoing costs for FRAN Service.

Vice Chair Brown acknowledged thoughtful work by the Committee's and thoughtful methodology presented by the consulting team. Vice Chair Brown states that this topic was discussed by the Board for quite some time and it is time to move forward with Committee and staff recommendation.

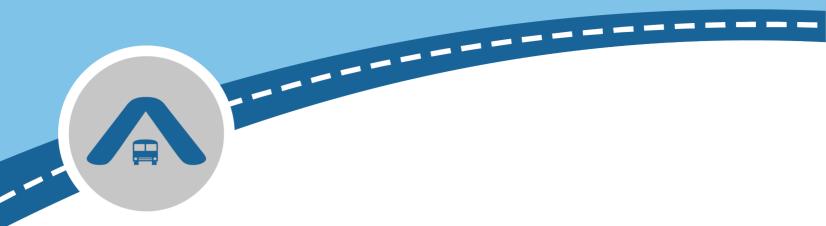
 Approve Resolution #2019-006 authorizing Anaheim Transportation Network (ATN) Executive Director to accept funding from Federal Transit Administration (FTA) for 2019 Low or No Emission Vehicle Program - 5339(c) and to execute a Cooperative Passthrough Funding Agreement with Southern California Association of Governments (SCAG) for \$2.0 Million

Director Diana Kotler explains the grant application request to FTA and states that \$176M was originally requested. ATN was the only agency in California to receive the grant award under the LoNo program. SCAG will serve as a mediator and a Memorandum of Understanding is currently being drafted and finalized by December; five percent of the grant will go to SCAG administration. Additionally, SCAG will be responsible for submitting status reports directly to FTA on our behalf.

2. Approve *#ElectrifyAnaheim* project budget and direct staff to amend Anaheim Transportation Network 2018/2024 Capital Improvement Program accordingly

Director Kotler states that the *#ElectrifyAnaheim* project can be broken down into four major programs and consists of nine different funding sources. Chairman Sanford asks Director Kotler to provide three advantages of this project. Director Kotler expressed personal interest in seeing our community benefit from the ecologically conscious decision to *#ElectrifyAnaheim* which will modernize ART fleet, help achieve cleaner air, as well as improve safety and security for ART service.

- 3. Approve Resolution #2019-007 authorizing ATN Executive Director to procure Construction Services Agreements not to exceed \$11.0 Million as follows:
 - a. Execute a Sole Source Guaranteed Maximum Price Construction Manager At-Risk Agreement with Uprite Construction for Design, Build Services as the General Contractor at both the Manchester Sliver and Claudina locations (CMAR) in the form attached as may be finally modified if approved by counsel and the Chairman;
 - b. Solicit and procure competitive bids under ATN Procurement Manual for prevailing wage construction services agreements with the various construction trades necessary under the CMAR;



- c. Solicit, procure and enter into consulting services agreements under ATN Procurement Manual with respective technical consultants to advise ATN and oversee *#ElectrifyAnaheim* project; and
- d. Provide regular reports to the ATN Board of Directors for progress under the CMAR, and to seek approval of the Trade Bids and Electrify Anaheim consulting contracts
