

15. ART Operational Update – Report provided by Parking Company of America (PCA) Aaron Chaves, Director of Operations, PCAM, LLC.

Aaron Chaves mentioned current and future staffing needs and ongoing effort to recruit Operators – the goal is to hire 60 more Operators to reach the 160-goal in 2020. Also mentions the re-establishment of the training program including current attendees (more than 22 trainees currently enrolled).


