- c. Direct staff, based on federal relief package funding, to develop and present to the ATN Board of Directors, a phased re-introduction of ART Assessment Fee structure, as appropriate;
- d. Authorize ATN to submit funding request OCTA to seek all appropriate federal relief funds as authorized by CARES Act for transit industry; and
- e. Call a Special Meeting of the ATN Board of Directors no later than April 30, 2020, to review COVID-19 state of affairs and determine further policy direction

### **DISCUSSION:**

Director Diana Kotler presented information in regard to the effects COVID-19 and ATN's future course of action. Director Kotler reviews staffing adjustments, contractor status, and financial updates including Business Interruption Insurance, FEMA Emergency Relief Funds, SBA Loan/Grant Funds, CARES Act – Transit Relief Package.

Director Shaheen Sadeghi inquires about ATN's year plan. Director Kotler explains that given the fluid situation surrounding COVID-19 the best ATN can do is provide plans based on predictions and provide continuous updates as new developments arise.


